# WHY IS ONTOLOGICAL CLIMATE MATHEMATICS **IMPORTANT?**

## LOGICAL SEQUENCE TO TELE


• CO<sub>2</sub>/GHG Greenhouse Effect → Global Warming/Climate Change Crisis → Global Governing Policy → Remove Sunlight & CO<sub>2</sub> from environment  $\rightarrow$  potential risk of foundation of all life (total extinction level event)

#### FOUNDATIONAL DUE DILIGENCE

- Is the cause sufficient to the undertaken risk to mitigate?
- Cause: Greenhouse Effect (radiative greenhouse effect RGHE)
  - (next slide explanations of following:)
  - Based on false theoretical and empirical initial premises
  - Inconsistent with well-established thermodynamic principles
  - Inconsistent with well-established empirical facts
  - False initial premises lead to incorrect conclusions
- There can be no global warming or climate change due to something which does not exist → a problem which can never be solved, and whose solutions will not have predictable consequences (although we can here)
   Vilification of CO<sub>2</sub> is false science

- False initial premises lead to false conclusions
- Non-ontological mathematics leads to false conclusions
- Consequences are fatal
- Solar input is equal to ¼ of itself (h/t Gödel)
- Consequence of: global mathematical surface average output → input
  Which implies: Earth is a flat plane tb possible
  Due to: not empirically ontologically realistic

### **RESISTANCE TO NULL HYPOTHESIS**

- Scientists: *infinitely resistant* to rational & obvious demonstrations that the RGHE is flawed and does not work or exist
  - really really badly want to keep it supported
- Policy Makers: *infinitely resistant* to alternative policy solutions not requiring solar radiation management & geo & strato & bio engineering
  - really really really badly want to do these things, given the RGHE justification

### DE FACTO

- de facto intent
  - describes practices that exist in reality, regardless of whether they are officially recognized by laws or other formal norms
- to:
  - Given that removing sunlight and CO<sub>2</sub> from the environment is the #1 way to fundamentally destroy almost *all life* at its basis planet-wide, where
    - Not *all* sunlight needs to be blocked (not much needs to be)
    - Not *all* CO<sub>2</sub> needs to be removed (not much needs to be)
  - End all life on Earth Total Extinction Level Event

### APPLIED ONTOLOGICAL MATHEMATICS

- We now exist in a state of a real-world exercise, a real-world test of our intelligence as a species with consequence to failure
  - This has gone beyond the entertainment phase of conjecture, speculation, and harmless intrigue by anonymous authors
  - This is the make-it-or-break-it test of this planet's genetic fitness to survive
  - Our enemy is going ahead with their plans
- Ontological Mathematics scenario anyone can comprehend
  - Flat Earth vs. Round Earth mathematics (practical ontological mathematics)
    - DOES IT MAKE A DIFFERENCE? WHY?
